# REGULATION

# Art. 1. Promoting subject

The Naturalistic Documentary Festival is promoted and organized by Delta 2000 limited liability Consortium Company with head office in San Giovanni di Ostellato (FE) in Strada Luigia, 8.

# Art. 2. Subject of works in contest

The festival is dedicated to the nature in Italy, in the rest of the world, and in particular in areas of NAP net (Networks of Adriatic Parks: Emilia-Romagna Po Delta Park, Veneto Regional Po Delta Park, Gargano National Park, Abruzzo, Lazio and Molise National Park, Foce dell'Isonzo Natural Reserve, Kozara National Park - BIH, Hutovo Blato National Park - BIH, Lokrum Natural Reserve - CRO, Cacak National Park, Butrinti National Park – AL).

Documentaries listed in categories A and B must tell and/or describe natural places, landscapes, phenomena (also meteorological and geologic), maintenance and study projects and any other wildlife aspect where living organisms are protagonists. Also works describing men and their activities in the world of the nature (to illustrate native populations, researchers, environmentalists, farmers, breeders, woodmen, park keepers, fishermen, hunters) are allowed.

Also works representing images picked up in conditions of captivity or with trained animals, if this is expressly declared in the form of registration, can be listed to the contest.

In category C (productions with videophones) also domestic and company animals can be described.

# Art. 3. Categories

Works, documentaries edited as complete of soundtrack (for example with in effects, music, live broadcast announcer, narrator, etc.), can be listed in one of the following categories:

# - Category A. Professional productions:

Works produced from independent filmmakers or from production societies that habitually develop the documentary activity in professional way. Works must last minimum 13 minutes and maximum 52 minutes.

# - Category B. Amateur productions:

Works produced from filmmakers or newcomers that develop the documentary activity primarily in the spare time and for fun. Works must last minimum 6 minutes and maximum 52 minutes.

# - Category C. Productions realized with videophone, webcam, photographic traps:

Sequences, also not edited, realized with videophone, webcam, photographic traps of particular

interest for the content that they represent (extraordinary natural events, particular animals behaviours, curiosities) and/or that film rare and/or hardly observed animal species. Works must last minimum 3 seconds and maximum 120 seconds.

#### Art. 4. Requirements and conditions of works

a. The official language of the Festival is Italian. Productions in foreign language are however admissible but they must be accompanied by an exhaustive writing summary in Italian. Productions that are not in Italian and in none of the following foreign tongues: English, French, Spanish must be subtitled or must be dubbed in Italian. A version with Italian comment can be requested to producers of winning works for the ceremony of awarding.

b. Productions can have already been transmitted by the television nets, or being in planning or be absolutely unpublished, if they have been completed before 15<sup>th</sup> April 2010.

c. Productions can be listed in Festival from the producer, from the co-producer, from the author, from the director or from who commissioned it.

d. Commercial and institutional sponsorships can be recognized in the works but any publicity is allowed outside of them.

e. Festival celebrates the beauty of the world of the nature, for such reason each listed work must have been carried out in the full respect of the health of withdraw subjects and of the environment when they live. Organizers reserve the faculty to refuse works that have been carried out with methods and systems ethically disputable.

# Art. 5. Modalities of registration, conditions for the participation and use of sent material

a. The festival is open to anyone, established trading companies as well as single authors and independent directors (better defined as filmmakers) deriving from any part of the world, that realized personally or produced movies, videos, animations for cinema, television or for every other utilization, inclusive the personal use.

b. <u>The participation to the contest is subordinate to the registration</u> that must be effected compiling the <u>card of participation</u>, enclosed to this regulation and available at the www.podeltabirdfair.it web site.

c. The delivery of the card of participation, together with the CD/DVD, can happen through postal delivery or by hand to the following address: **Naturalistic Documentary Festival 2010Contest** c/o Delta 2000 limited liability Consortium Company, Strada Luigia, 8 San Giovanni di Ostellato (FE) within and not over 5.00 p.m. on Thursday, 15<sup>th</sup> April 2010.

d. Works reached and not equipped by the dispatch in papery form of the card of compiled registration in every part will be automatically excluded by the contest.

e. The organization reserves the right to modify the category the listed work competes to.

f. Each work must be furnished in two copies on DVD (burned with the usual programs available in commerce and readable with DVD reader, pc and Mac) that won't be returned at the end of the Festival if not expressly requested and with postal expenses in charge of the participant. In case the quality of the reproduction is not suitable, the delivery of the material in betacam or dvcam can be requested to the participant.

g. Affiliates must furnish at least two digital photographic images for each production that withdraw the author-director or presenter and a salient moment of the production authorizing the



organization to use them, also in web, for the presentation and the promotion of the Festival also in the future editions. Photos won't be returned.

h. Affiliates allow to the organization to use maximum three minutes of every single listed work for the free use in television programs or in other demonstrations connected to the Festival, included web and initiatives connected to the promotion of the nature safeguard.

i. Each listed work must be accompanied by the above mentioned cards and images. Organizers reserve the right to not accept works without the necessary enclosures.

#### Art. 6. Responsibility of participants

a. Who lists himself is in charge of the timely and well-preserved arrival of the works and the organization of the Festival, while guaranteeing the maximum attention in the management of the materials, refuses all responsibility for any damages, loss or non-arrival.

b. Who lists himself to the Festival excludes the organization, also, from any pretension and claim that can be relieved by third people.

#### Art. 7. The Jury

a. The jury, composed by personalities of the scientific world, environmental associations and television, will reward the first three works classified of professional productions, amateur productions, productions with videophone, webcam, photographic traps (categories A, B, C).

b. Prizes and recognitions are decided by the Jury of the Festival whose decisions are final.

c. A special prize Biodiversity will be assigned to the documentary of the categories A, B for the message of safeguard of biodiversity and a special prize Wet Lands to the documentary of categories A and B that better describes life, characteristics, problems of wet lands (lagoons, pools, marshes, saltworks, peat bogs) in Italy.

Works can be sent starting from 05/02/2010 and they obligatorily must reach, in accordance with the modalities indicated in the art.4, at Naturalistic Documentary Festival c/o Delta 2000 limited liability Consortium Company, Strada Luigia, 8 San Giovanni di Ostellato (FE) by 15<sup>th</sup> April 2010.

#### Art. 10. Awarding

The ceremony of awarding will have place on Saturday 1<sup>st</sup> May 2010 at 6.30 p.m. at Sala Polivalente, Bellini's Palace, Via Agatopisto 7, Comacchio (FE).

Only the authors of the winning works will be contacted by telephone or e-mail. Results will be announced on www.podeltabirdfair.it. site.

#### Art. 11. Final dispositions

The participation to the Festival presupposes the general acceptance of the present regulation.

#### Art. 12 L.D. informative 196/2003 on the Treatment of personal details.

According to the art. 10 of the Law 675/96, "Protection of the people and other subjects in relating to the treatment of personal details" and following change with L.D. 30<sup>th</sup> June 2003 n. 196, the personal details supplied by Competitors with the compilation of the card of registration, collected and treated with computer tools, will be used to individualize the winners and to identify the authors of works in the different occasions when these will be projected or published and for communications related to the same contest.

The Competitor has the right to access to data that concern him and to practice the integration, rectification, cancellation rights etc. guaranteed by the art. 13 of the above mentioned Law, to the holder of the treatment. Holder of the treatment is Delta 2000 limited liability Consortium Company.
